Learn about your rights under the new Minnesota Debt Fairness Act protections and how they can benefit you.

2. One-on-One Consultations

Meet with volunteer attorneys for personalized advice. Get a brief review of your debt situation, general legal guidance, and recommendations for specialized legal help.

3. Expungement Assistance

If you have a criminal record from a state court, find out if you qualify for expungement. Sealing your record can improve your chances of obtaining housing, employment, and certain job-related licenses. Our clinic may help you get your record sealed at no cost.

- Bring a printed copy of your credit report (printing services will be available on-site).

Tej Yam Yuav Tham Txog:

1. Qhia Txog Koj Cov Cai Uas Koj Muaj

Kawm paub txog koj cov cai uas koj muab ntawm txoj cai tshiab Minnesota Debt Fairness Act thiab kom paub seb yuav pab tau koj li cas.

2. Kev Sab Laj Ib-Nrog-Ib Leeg

Sib ntsib nrog cov kws lij choj uas tuaj pab dawb kom tau txais tswv yim tshwj xeeb rau koj. Lawv yuav pab xyuas me ntsis txog koj cov nuj nqis, muab kev taw qhia txog kev cai lij choj, thiab yuav pab qhia seb koj yuav nrhiav tus kws lij choj li cas txog koj qhov teeb meem.

3. Kev Pab Txog Kev Tshem Tawm Lub Txim

Yog koj muaj ntaub ntawv raug ntes tas los los ntawm tsev hais plaub hauv xeev, saib seb puas tsim nyog koj tau txais qhov tshem tawm Lub txim. Rho koj cov ntaub ntawv txim txhaum yuav pab txhawb koj txoj kev nrhiav tsev nyob, hauj lwm, thiab qee hom ntawv tso cai muaj feem rau hauj lwm. Peb lub chaw ua hauj lwm yuav pab seb tshem tawm puas tau koj cov txim yam tag los yam tsis yuav nqi.
